Complaints about a grantee's compliance with statutory and regulatory requirements related to public utility and uniform treatment – including rate or charge amounts/formulas, a grantee assessing a rate or charge amount/formula that does not appear in its zone schedule, and a grantee not affording uniform treatment under like conditions – may be presented to the FTZ Board under 15 CFR 400.45 (which also allows for complaints to be made on a confidential basis, if necessary).

The Port of Stockton can and will, however, provide any such requested or required ancillary FTZ services, including but not limited to, documentation generation, activation training, compliance reviews, et cetera, through its Foreign Trade Zone consultant. The consultant fees for any such contracted activities are the sole responsibility of, and shall be charged directly to, the requesting FTZ user.

FTZ GRANTEE FEES AND FEDERAL CITATIONS

The fee amounts contained in the Foreign Trade Zone Tariff Schedule are Zone-specific and shall be in addition to any applicable charges, fees, and expenses otherwise due to the Port of Stockton. The Port of Stockton, as Grantee of FTZ #231, administers the Foreign Trade Zone in accordance and compliance with federal FTZ regulations 15 CFR Part 400 and 19 CFR Chapter I.
