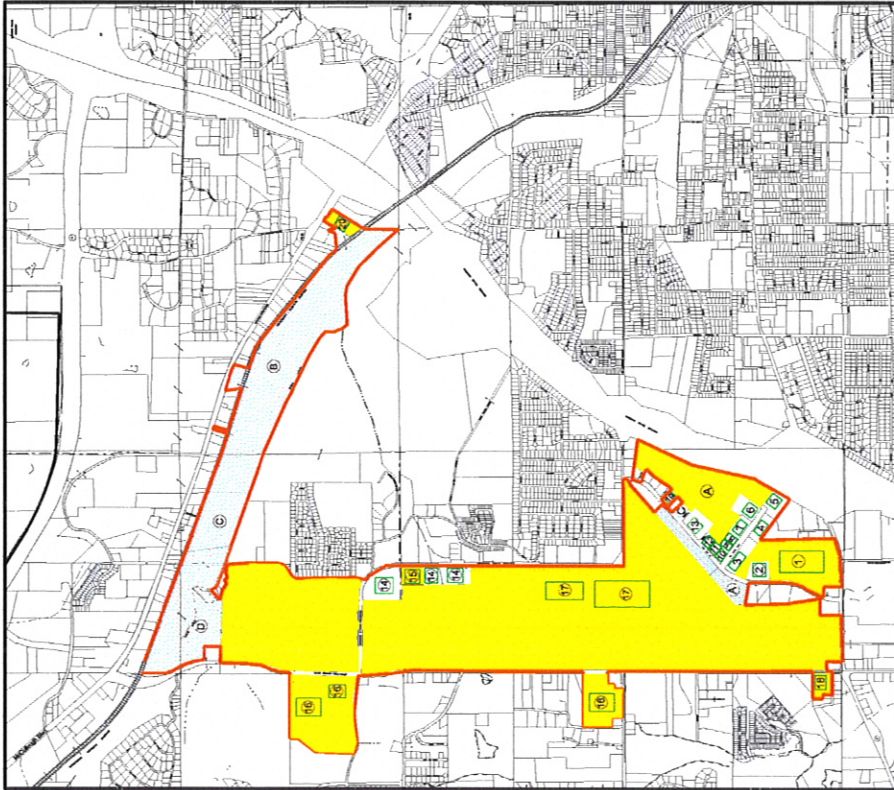
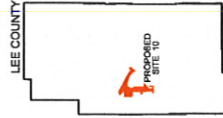


AIRPORT INDUSTRIAL PARK GENERAL PURPOSE ZONE
